Part of Lot 33, Concession 1, Part 2 RP21R10701, Hungerford

To amend the zoning from Limited Service Residential (LSR) to Special Limited Service Residential Holding (LSR-8-h).

The special provisions for this zoning change include the following requirements: building setback from the Environmentally Sensitive-Evaluated Wetland (ES-EW) Zone is a minimum of 40 m (131 ft.); natural vegetation buffer adjacent to the ES-EW be maintained; and the holding provision will remain until a development agreement between the property owner and the Municipality is established.

The applicant and the agent attended the public meeting in support of the application for rezoning.

2. Shannon Amikons – issue with cats and litters & request for children playing signs.

Shannon Amikons, a resident of the hamlet of Marlbank, attended the meeting to address her concerns with the number of feral cats in the hamlet and the problem of the cats reproducing at an uncontrollable rate. She has been trying to obtain support from area agencies for fundraising to establish a program to help control the cat population.

Council advised Ms. Amikons that there is no by-law in the municipality to deal with cats, however, they suggested that she attempt to become a satellite location of a charity devoted to the cause and continue to try to work with existing organizations. They also advised her of the Tweed Pet Food Bank which had recently been established by a private individual in the area to assist with feeding costs.

Ms. Amikons also requested the placement of children playing signs in the hamlet of Marlbank and Council agreed to have Public Works staff install the signs.

3. Jim Keniston – Tweed Trunk or Treating.

Jim Keniston attended the meeting to request support for the Tweed Trunk or Treating event planned for Halloween evening at Tweed Memorial Park. He reported that participation has increased each year of the event and thanked Council for their support in prior years.
